

AUTHORIZING RESTARTS FOR DRAMATIC SCHOOL IMPROVEMENT

re • start (verb)

- 1. a new start or beginning
- 2. closing one underperforming school and opening a new school, often in the same building, to serve the same students under new management

What is Restart?

- District and charter schools
- New school operator
- New school governance (with some exceptions)
- Serving the same students
- Whole-school and phase-in restarts


Why Restarts? The Promise ...

<u>If</u> school restarts place **high-performing school operators** in charge,

... with sufficient autonomy & resources,

... under **conditions** for smooth transition & community support...

<u>Then</u> restarts can lead to **swift & dramatic improvements** in low-performing schools

SCHOOL RESTART NATIONAL DATA ANALYSIS

Public Impact collected descriptive and performance data about all restarts attempted in U.S. schools, starting in 2010.

- Identified 207 school restarts
- Collected data on state assessments and graduation rates from SEA websites
- Calculated state percentile rank (SPR) scores on student proficiency and graduation rates for all relevant years (e.g. pre/post restart)





RESTART DATA ANALYSIS: DESCRIPTIVE DATA HIGHLIGHTS

- Most restarts initiated by authorizers as part of a multi-school turnaround strategy
- Steady annual rate of restarts since 2010 (~20 to 30 per year)
- Half authorized by LEAs (50%), and nearly half by SEAs or state authorities (43% combined)
- Most restarts were of District-managed schools (151 schools, 73%); in addition to 39 charter restarts (19%), and 17 Louisiana RSD schools that were converted to charters





RESTART DATA ANALYSIS: DESCRIPTIVE DATA HIGHLIGHTS

- Most authorized as a charter school (132 schools, 64%); remaining through a contract
- Most restarts initiated as whole-school turnarounds (169 schools, 82%)
- Most restart operators (60%) had less than six months between selection and school opening
- On average, student enrollment changed vert little post-restart
- Restarts conducted in 30+ cities, but concentrated in five locations (125 of 207 schools); Chicago, New Orleans, Detroit, Philadelphia, Memphis



SCHOOL RESTART DATA ANALYSIS: ACADEMIC PERFORMANCE PRE/POST RESTART

• On average, the state percentile rank (SPR) of restarts schools increased by 10 points in ELA and by 11 points in math over five years.

SCHOOL RESTART DATA ANALYSIS: ACADEMIC PERFORMANCE PRE/POST RESTART


• By year 3, 41% of restarts achieved 10 or more percentile point gains in Math, and 23% demonstrated 10 or more point gains in ELA.

SCHOOL RESTART DATA ANALYSIS: YEAR 3 VS. BASELINE


 Schools (dots) above the line performed better in Year 3 of restart vs. baseline (pre-restart).







SCHOOL RESTART: WHAT'S THE PROMISE?



- What should be authorizer expectations for restart improvement? Is an average gain of ten percentile points enough over three years?
- How do authorizers create conditions to improve restart success rate?



CHARTER RESTARTS PHILADELPHIA - BIG PICTURE

- SDP launched a Renaissance Schools Initiative in 2010, 22 District schools have been converted to charter under program, 21 remain open and operating under a charter
 - Renaissance charters have historically been granted through an RFP not the annual new charter application process
- Charter to charter restarts have also been permitted, 2 charter schools have changed CMO to improve the charter school's performance (both Renaissance charters)
 - Charter to charter restarts are initiated by the charter school's board and also typically occur through a school-managed RFP process






PHILADELPHIA STUDENT DEMOGRAPHICS BY CHARTER TYPE

Renaissance schools have significantly higher rates of students living in poverty and English Language Learners as well as higher rates of minority students.
