

### DC PUBLIC CHARTER SCHOOL LANDSCAPE

- DC PCSB Sole authorizer in DC
- 66 independent LEAs across 120 campuses
- Approx. 43,000 PK-12, Adult and Alternative education students
- 46% of public school students attend charter schools
- Seven member Board appointed by Mayor
- Office staff of approx. 40 people
- Created in 1996, DC PCSB is an independent body governed by the <u>School</u> <u>Reform Act</u>.
- The first public charter school opened in 1996



Our vision is to work collaboratively with the community to provide high-quality and innovative school options that meet the diverse needs of our students, our families, and our city.








### REVOCATION INTERVENTIONS

OEI employs several interventions prior to charter school revocation, the first being a formal Notice of Deficiency to the school.

#### Examples of Notice of Deficiency Triggers

#### **Academics**

- "F" on State report card
- "DNMS" on Core Question 1 of Performance Framework
- Repeated failure to meet academic standards

#### **Finance**

- Failure to make payments to creditors
- Missing enrollment targets
- Significant SBOA audit findings
- "DNMS" on Core Question 2 of Performance Framework

#### Governance

- Schools and/or board is out of compliance with its charter or applicable laws
- Significant concerns with school and/or board leadership
- "DNMS" on Core Question 3 of Performance Framework



## PERFORMANCE IMPROVEMENT PLAN (PIP)


Level 2: Notice of Probationary Status Level 3: Notice of Potential Revocation of Charter

Level 1: Request for Corrective Action

Levels and number of required actions increase with the severity of the concern or the lack of progress on action items.

### COLORADO CHARTER SCHOOL INSTITUTE

- Statewide charter school authorizer
- Created in 2004 as independent state agency
  - Purposes: Alternative mode of authorizing; assist districts in best practices
  - Started with 2 schools in 2005-06
- Schools can apply to CSI in districts without "Exclusive Chartering Authority" (ECA), or who have waived it
  - 169 out of 178 of districts have ECA
- Governance: 9-member board; 7 appointed by Governor, 2 by Commissioner
  - No more than 5 members of same political party + additional relevant experience

41 Charter Schools in 21 Towns and Cities	238 Charter Schools across 48 Districts and CSI
17,000+ Students	115,000 Total Charter Students (12.7% of all public school students)


