

WHAT IS REPLICATION?

- Replication: Using a current successful school expand and increase the number of quality choices.
- Adding grades (scaling)
- Additional campuses (duplication)
- Replication should be at least as important as opening a brand-new school (incubation) or recruiting a charter network from out-of-state (recruitment).





STRATEGIES TO IMPACT EQUITY AND QUALITY

- 1. New school incubation: Developing and opening new schools to provide better quality choices.
- 2. Recruiting charter network: Bringing in models that have worked to improve student outcomes in other regions
- 3. Replication: Using a current successful school expand and increase the number of quality choices.
 - -Adding grades (scaling)
 - -Additional campuses (replication)





DC PUBLIC CHARTER SCHOOL BOARD

- Who are we?
- Sole authorizer in DC
- 66 LEAs across 120 campuses
- 46% of public school students attend charter schools
- Office staff of about 38





THE FIRST STEPS IN THE PROCESS

- 1. Schools contact PCSB to share their initial plans
- 2. We discuss internally whether the school meets the standards
- 3. We share initial feedback with the school (whether our Board is likely to vote yes or no, based on a surface assessment of their performance)
- 4. We provide a timeline (submit the application, notify the necessary DC entities such as ANCs, public hearing date, vote date)


STANDARDS FOR APPROVAL

DC PCSB will generally approve a campus replication for schools that fit the following criteria:

- Are financially viable with sufficient financial standing for the past three years
- Are in compliance with all applicable laws and PCSB policies
- Have Performance Management Framework (PMF) scores of Tier 1 for the majority of the past five years, including all existing campuses









REPLICATION AMENDMENT APPLICATION (SEE HANDOUT)

Key questions

- How the school will maintain academic quality
- Changes to the organizational structure, staffing, and PD
- Financial impact—5 year budget, proposed cost including facilities, contingency plan if the school enrolls fewer students than anticipated
- Facility—If the school has identified a new location, additional standards will be assessed including community engagement
- Number of students that will be served and timeline for expansion (may require an amendment to school's enrollment ceiling)




GROWTH IN DC

New Schools vs. Replications/ Expansions (since 2013)



 - Disproportionality of exclusionary discipline among subgroups
 - Evidence of community engagement





THOMAS B. FORDHAM FOUNDATION


- Who are we?
- 1 of 65 Authorizers in Ohio. 1 of 5 Authorizers who can add schools to its portfolio.
- 14 LEAs, over 4000 students
- Community schools may only be opened in a "Challenged School District," based on academic performance, location in the 8 largest urban districts or location in the community school pilot area.
- Office staff of about 5





TBFF STUDENT COUNT BY ENROLLMENT TYPE


Student Enrollment - All Schools





TBFF EXPEDITED APPLICATION PROCESS

- To qualify for the expedited application process, the following criteria must be met:
- At least one of the applicant's schools has been sponsored by Fordham for at least 3 years;
- All schools sponsored by Fordham are meeting the terms of Exhibit IV (Academic and Organizational Accountability Plan);
- The model for the proposed school is substantially similar in academics, finance, and governance to the applicant's existing schools.





APPLICANT APPROVAL RATES


Applications 2013-2017	Approved	Denied
Start Up	3	12
Replication	3	0

- Replication applicants do not include grade expansions or scaling, new LEAS only
- 2 of the 3 replication schools were from the same operator





REPLICATION SCHOOL PERFORMANCE





REPLICATION SCENARIO 1

- Flagship school's academic performance has grown each year, but they are not in the top 20% of the local schools
- School is a arts focused model
- Market assessment shows a different region does not have any arts focused model schools
- The area were the flagship school is located has a significant amount of school migration and transition as compared to other parts of the city
- School performs well organizationally and has a strong culture
- No financial or audit issues
- The school does not own their current facility



REPLICATION SCENARIO 2

- The school is one of the highest performers in 5-8 in the city
- No local high schools in the immediate area (within 5 miles) have a graduation rate over 80%
- The operator does not have a high school in its portfolio
- The school is an Expeditionary Learning school and would want the high school to have the same model
- Urban setting with a diverse population and over 70% free and reduced
- Transportation is not provided by the district for high schools
